FC.15 FROM OTHER COMMITTEES:

 Personnel Committee, May 8th: Formally approve new HR Advisor. The Clerk briefly explained. It was proposed by Cllr K Dolby and seconded by Cllr M Allan that the HR advisor – Peninsula – be appointed for a 3 year period.

Vote 18 for. The Resolution was passed.

 Services Committee, April 24th: Cemetery – Millfield Gate – whether to open longer hours in the week.

Cllr G Titmus explained the reason for the Services Committee decision. They had looked at the comments from the Services team and although they didn't disagree, they decided to disregard the,. The Committee recommended the gate opens and closes with the main gates.

Cllr J Charlesworth recommended remaining as they are – he was not aware of any upsurge of support for longer opening hours.
Cllr M Allan said the TC had to manage a risk. The risk increases if the gates are opened longer. It is opened to allow people to visit graves not as a short cut. He supported the recommendation to remain as they are.
Cllr D Vere-Critcher said he had been a member of the group who campaigned to have them opened. Members of that group and those close to them are happy for it to stay 10am-2pm weekdays.
Cllr I Dolby said 10-2 was just about right.
Cllr D Suiter said more people in the cemetery for longer hours made it

safer for lone workers as someone was about, it made the cemetery safer.

There was some discussion about slightly longer opening but it was felt this would allow parents and schoolchildren to use the cemetery as a

It was proposed by Cllr J Charlesworth and seconded by Cllr M Allan that the Millfield gate remains open as currently on weekdays: 10am-2pm.

short cut in one direction but not back, which may cause more problems.

Vote: 11 for; 4 against; 3 abstentions. The Resolution was passed.
