# A.6 NEW OR AMENDED APPLICATIONS FOR DISCUSSION.

**12/0078/HOUS** – Mr Gillis. Erection of single storey rear extension. 8 Gibson Close, Holdingham.

It was proposed by Cllr D Birks that "no objections" be raised to this application. Seconded by Cllr J Charlesworth.

Vote – 17 for. The Resolution was passed, "no objections" to be forwarded to NKDC.

**12/0092/FUL** - Mr Bellamy. Erection of a poultry unit (for egg production), egg storage building & 2 feed silos (resubmission). Boiling Wells Farm, Grantham Road, Greylees.

After discussion, it was proposed by Cllr I Dolby that an "objection" is made on the grounds of overdevelopment and pollution concerns. Seconded by Cllr D Birks.

Vote – 10 for and 7 abstentions. The Resolution was passed, the above objection to be forwarded to NKDC.

**12/0103/FUL** – Melbourne Holdings Ltd. Erection of rear extension to warehouse. Starlite Pride Parkway, Enterprise Park.

It was proposed by Cllr D Birks that "no objections" be raised to this application. Seconded by Cllr M Allan.

Vote – 17 for. The Resolution was passed, "no objections" to be forwarded to NKDC.

**12/0110/FUL** – Sleaford Medical Practice. Erection of single storey extension & reconfiguration of existing car parking layout to provide 5 additional spaces. Sleaford Medical Group, 47 Boston Road.

After discussion, it was proposed by Cllr M Allan that an "objection" is made on the grounds of overdevelopment of the site with consequences of traffic problems. New Street is not a viable alternative exit/entrance for traffic. Also, pedestrian safety is also a major concern.

This to application to be dealt by the Planning Committee and a representative from the Town Council to speak. Seconded by Cllr I Dolby.

Vote – 17 for. The Resolution was passed, the above objection to be forwarded to NKDC.
