# SLEAFORD TOWN COUNCIL MEETING OF THE APPLICATIONS COMMITTEE

- **A.1 APOLOGIES.** Apologies, with a reason, had been given to the Clerk from Councillor Claire Darch. This was accepted.
- **A.2 DECLARATIONS OF INTEREST.** To receive disclosable pecuniary interests in accordance with the Localism Act 2011. None were received.

## A.6 NEW OR AMENDED APPLICATIONS FOR DISCUSSION.

**13/1143/ADV – Jolly Scotsman, Lincoln Road.** Erection of replacement signs (including 3 illuminated). Greene King.

The Chairman asked if the totem pole sign may distract motor traffic.

It was proposed by Cllr J Mathieson and seconded by Cllr D Birks that an objection be made to this application on the following grounds: that the totem pole sign may block the view of traffic on the road and entering/exiting the car park may be distracting. The curve in the road increases the hazard and there has already been a fatality on that stretch of road.

Vote – 12 for. The Resolution was passed. The objection and comments to be passed to NKDC.

**13/1047/FUL – Lincs Van Hire, Pride Parkway.** Erection of office building and garage/car wash. Lincs Van Hire.

It was proposed by Cllr Jan Mathieson and seconded by Cllr Ken Fernandes that there be "no objections" to this application.

Vote – 11 for, 1 abstention (Cllr D Birks). The Resolution was passed. "No objections" to be passed to NKDC.

**13/1099/ADV – Unit 4, Lincoln Road.** Erection of two internally illuminated fascia signs. Domino's Pizza UK & Ireland Ltd.

It was noted that the Town Council have already objected to the original application due to the quantity of food outlets already in that area.

It was proposed by Cllr Ken Fernandes and seconded by Cllr Grenville Jackson that there be "no objections" to this application.

Vote – 6 for, 1 against, & 5 abstentions. The Resolution for 'no objections' was passed.

**13/0969/FUL – 15 Northgate, Sleaford.** Conversion of existing first floor retail show room to contain first floor flat. Panton Properties.

The Chairman explained the location of the property.

It was proposed by Cllr Trevor Mayfield and seconded by Cllr Doug Vere-Critcher that there be "no objections" to this application.

Vote – 11 for, 1 against (Cllr D Birks). The Resolution was passed. "No objections" to be passed to NKDC.

13/0579/HOUS (Amended) – 17 Hervey Road. Erection of single storey rear extensions. The Amendment is: Roof extended to provide log store and hipped roof to study and additional roof light.

It was proposed by Cllr Jan Mathieson and seconded by Cllr Doug Vere-Critcher that there be "no objections" to this application.

Vote – 12 for. The Resolutionwas passed. "No objections to be passed to NKDC".
