FC.4 COMPULSORY PURCHASE ORDER

To consider request for Resolutions made as Briefing Paper, previously circulated.

Following discussion, it was agreed that Members were in favour of the recommendations and **IT WAS RESOLVED THAT:**

Sleaford Town Council will make an 'In Principle' objection to the NKDC CPO relating to the land for the SESRR and to the LCC SRO relating to the SESRR and that these decisions are passed to the Council's Legal Advisor, as requested, so that he is prepared if and when the CPO is served on the Council and the SRO is published.

IT WAS FURTHER RESOLVED THAT:

The CPO Working Group meets immediately and makes recommendations to Full Council for:

- a) the identification of the information that needs to be put together to fully explain to the electorate the concerns of this Council that relate to the NKDC proposals for the SESRR and their regeneration proposals, and the effects on the town and the well-being of the townsfolk;
- b) how the dissemination of this information is to be passed to the townsfolk so that there is a full understanding of the NKDC proposals, and
- c) using the above information set out proposals, methodologies and estimates for cost for ensuring that this Council understands what level of support it has from the electorate for proceeding with an objection at a public inquiry to the CPO and the SRO once the electorate is informed of the Council's concerns".

Vote: Unanimous, The Resolution was Carried.

There being no further business, the Chairman thanked all for attending and closed the meeting at 8.05p.m.
