Vote – 8 for and 3 abstentions. The Resolution was carried, LCC to be notified accordingly.

8a.2 **15/0413/FUL – 6 Mill Court, Carre Street. (Navigation Ward)** J Hodgson & Sons Ltd. Change of use from retail shop to A3 restaurant.
