1. Lead Introduction

4. Open Space – 5 Year Plan

STC's 5-year Capital Programme together with the balances and reserves were discussed in detail.

It was agreed that the Panel, together with the Services Supervisor, carry out site inspection on STC's play areas to review the play equipment. The review to include the need for new equipment, refurbishment of current equipment and a 'wish list' of possible future items.

The Panel also requested for the Clerk to investigate the cost of introducing charges for both the Monument Toilets and Money's Yard.

The Clerk confirmed a meeting is scheduled with an Architect in the next couple of weeks. The Panel gave their ideas of how to utilise the Town Hall that would benefit members of the public and staff.

7. Councillor Allowances

The Panel agreed for the Clerk to submit a report on Councillor Allowances to Council on 2nd August 2017.

8. Cemetery

The Clerk provided a brief report covering current works at the cemetery.

Future works needed include, Internal gate – formation of pedestrian access to also allow gate to be closed, resolve drain blockage on right hand side grass verge and repairs needed to right side of drive plus the drive and roundabout generally requires remedial works.

The Panel agreed to meet on site at the Cemetery to look at pathways and report back to the next panel meeting

It was suggested to have double yellow lines to prevent parking at the cemetery.
